

NAB AFL AUSKICK CLUB CONNECT SURVEY PROMOTION

TERMS AND CONDITIONS

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is only open to Victorian and Queensland residents. Employees and their immediate families of the Promoter and their agencies associated with this promotion are ineligible.
